WHEREAS, Tina is a graduate of the National American Legion College; and



WHEREAS, Tina has been endorsed by each Post in the District; and


WHEREAS, Tina has a passion for veterans and has shown leadership to ensure the best care through the programs of the American Legion; now, therefore, be it
