	Department Conventions of The American Legion Department of Colorado, with vote to be exercised by them with their respective Posts,
Section 9.	The Department Convention shall be the final judge of the election and qualification of the Delegates.
Section 10.	A quorum shall exist at a Department Convention when 30 of the Posts are represented and their
	Delegates and Alternate Delegates have been certified to the Department Headquarters.
